

Resolution 4) The R & D committee had presented the reports which was found satisfactory. (Annexure 3)







4 Faculty members has completed their Ph.D. in the year of 2019-20.

It was reported that 14 patent were published while 1 were granted in the year 2021. IQAC shown its deep satisfaction in this regard.

- a) Total of 652 students taken admission in the year 2021 22 which is 84.02% of intake (Regular + TFW). In the year 2020-21 the admission was 78.99%.
- b) Increase in seat in CSE has resulted quite positive and at par with the expectation.
- c) Admission in IT and MCA has effectively increased.
- d) Significant fall in admission were observed in ME and M.Tech Programs.
- e) No admission is found in AEIE department.
- f) Admission of lateral students marginally increases from 50 to 58 in the year 2020-21.


The IQAC expressed its satisfaction to the overall admission numbers.


